Invitation for Bids for the Construction of Jhorung Khola RCC Bridge

1. The Bigu Rural Municipality **has allocated funds** towards the cost of Construction of Jhorung Khola RCC Bridge, and intends to apply part of the funds to cover eligible payments under the Contract **for Construction of following works**. Bidding is open to all eligible as per Section V of bidding document.
2. **Bigu Rural Municipality** invites electronic bids only from eligible bidders for the construction of **Jhorung Khola RCC Bridge** under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.
Only eligible bidders with the following key qualifications should participate in this bidding:
 - Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years including VAT is NRs. 4,52,00,000/- and Minimum Work experience of similar size and nature is 2 Nos. Multispan Bridge with span 25m or above within the last 10 years, each with a value of at least NRs. 3,00,00,000/-
3. Eligible Bidders may obtain further information and inspect the Bidding Documents at the office of **Bigu Rural Municipality, Laduk, Dolakha** or from official website www.bigumun.gov.np or may visit PPMO e-GP system www.bolpatra.gov.np/egp.
4. Bidder may download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost of bidding document NRs. 5,000/- (Five thousand) in the Project's Rajaswa (revenue) account as specified below .

5. Pre-bid meeting shall be held at **Bigu Rural Municipality** at **14.00hrs on 2076/03/01**
6. Electronic bids must be submitted through PPMO's e-GP system www.bolpatra.gov.np/egp on or before **12.00** on **2076/03/10**. Bids received after this deadline will be rejected.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend at **14.00hrs on 2076/03/10**. at the office of **Bigu Rural Municipality, Laduk, Dolakha**. Bids must be valid for a period of **120 days** after bid opening and must be accompanied by a scanned copy of the bid security in pdf format amounting to a minimum of **NRs. 9,50,000/-**, which shall be valid for 30 days beyond the validity period of the bid.
8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
